I agree to Boze Bookkeeping, LLC Non-Disclosure Policy Below:

**A. Purpose.** Boze Bookkeeping, LLC acknowledges and agrees that Confidential Information supplied by the Disclosing Party is being made accessible solely on the understanding that the knowledge derived therefrom is to be used exclusively for the purpose of evaluating the business for a potential proposal, transaction, negotiation, investment, or other business opportunity and the terms thereof shall be written out in a separate agreement.

**B. Confidentiality.** Boze Bookkeeping, LLC agrees not to disclose Confidential Information to any third party (individual, company, corporation, or other entity) or to use Confidential Information for any purpose other than the reasons mentioned in section (A) of this article. **C. It is the duty and responsibility of the Boze Bookkeeping, LLC to inform each person to whom Confidential Information is transmitted that the information is confidential and that its use and disclosure are subject to the terms and conditions of this Agreement.

**D. Legal Disclosure.** Boze Bookkeeping, LLC may be required by law (through court or administrative order, subpoena or other such legal proclamation) to disclose Confidential Information for the purposes of aiding or taking part in a case involving a violation of the law. Boze Bookkeeping, LLC shall, if legally permissible, promptly notify the Disclosing Party of any such demand for disclosure so that the Disclosing Party may seek to make such disclosure subject to a protective order or other appropriate remedy to preserve the confidentiality of the Confidential Information. Notwithstanding the foregoing, if the Disclosing Party is unable to obtain a protective order, the Boze Bookkeeping, LLC may be compelled to disclose such Confidential Information and will not be held liable.
